The Budget workshop started at 7:10. Each line item was gone over for each fund and explained. There were a few questions asked but all agreed with the proposed Budget. The Public hearing was opened at 8:10 for Public Comment. There was only one person present and he had no questions. The hearing was left open at this time and the Board went on to regular business at 8:15.

The minutes from the September meeting were read. Councilman Jackson made motion to accept the minutes. Councilman Hartwell seconded the motion. Roll call all ayes motion carried.

Motion was made by Councilman Mahany to leave Executive Session and seconded by Councilman Jackson. No decisions were made while in Executive Session. The regular meeting was resumed at 8:45.

The Supervisors report was looked at. Councilman Mahany made motion to accept the report. Councilman Hartwell seconded the motion. Roll call all ayes motion

Chmn Willis went back to the Budget at this time. There was no one present at this time so a vote was taken. Motion to accept the budget was made by Councilman Mahany and seconded by Councilman Stauring. Roll call all ayes Budget passed for 2016.

The Board audited General Fund Abstract #10 (216-233) for \$6,373.61, Highway Fund Abstract #10 (131-135) \$ 41,327.56 T/A abstract # 10 (25) for a total of \$110.00.

There being no further business before the board at this time CouncilmanMahany made motion to adjourn, Councilman Jackson seconded it roll call all ayes motion carried Meeting adjourned at 9:00PM.
