The Pledge of Allegiance to the Flag was observed.

There was no one present from the public.

Dog Control /Constable Lackey stated that he is working on the dog delinquent list. There are no car problems at this time. He does have a case going to Tuesday for court. Bruce also advised the board of a phone call he received from Chicago Police Department asking him to check on a person who was soliciting funds on Facebook for a dog mission in our town. The Supervisors reports were looked at for December and January. Councilman Hartwell made motion to accept the report. Councilman Rauber seconded the motion. Roll call all ayes motion carried.

Chmn advised the board received from Perkinsville Fire District. He asked Nancy to write them a letter with the amount of parcels being discussed for coverage and he will attend a meeting in the future.

Also there were 2 letters asking for contributions and the board said no.
