Also present: Ray Acomb (Hway Supt.), and Attorney John Vogel and from the Public Mike and Merle Wyant

The Pledge of Allegiance to the Flag was observed.

From the Public: The Wyants' briefly talked to the board concerning the re-val of taxes. They thought that the assessor may be at the meeting. They will come in to see her to discuss their taxes.

Dog Control /Constable Lackey stated he is monitoring cars for another month before sending letters out. The two people he issued tickets too were in court and did get the dogs licensed. He has one more person left to contact from last year delinquent list yet. Councilman Jackson made motion to accept the report. Councilman Hartwell seconded the motion. Roll call, all ayes motion carried.

Attorney Vogel advised the board that he again had been contacted that Mr. Freckelton wants to enter into an easement with the town regarding the towns right away near his property on Sick Road He wants to be in control and can do whatever if he doesn't feel it is correctly done. Again the board told John the answer is NO to anything Mr. Freckelton wants.

Highway Superintendent Acomb advised the board of a complaint he had received on Kurtz hollow Road. Most of the problems have been addressed. He also stated the tractor he went to bid on went to high. The one they are using now is rented from George and Swede. The buying price of it would be \$38,000. When we pay the rental they would drop it down to \$35 to \$36,000. He stated that Oliver's had a Massey 4610 for \$46,500. John Deer a 5100M utility for \$64,332., a 5100E utility for \$54,094.97 and a 6105M for \$77,582.95. Councilman Mahany told Ray that Oliver's also had a Massey that belonged to Bobby Goodrich that they would sell for \$ 42,500. Ray advised he would go look at it and purchase it if it was acceptable. Quotes for an excavator were a Volvo EW160D with HGAC pricing would be 166,412. Caterpillar M316D \$216,684. Nothing had come back for m John Deer. Our excavator would probably sell for \$ 30 to \$35,000. Fremont would have to buy us their share for half that. Ray will keep checking on prices. Councilman Hartwell made motion to accept Ray's report. Councilman Jackson seconded the motion. Roll call all ayes motion carried.

Nancy advised the board that there was no supervisor's report available at this time as the statements came too late to balance before the meeting.

The CEO report was looked at there were no questions concerning it. Councilman Jackson made motion to accept the report. Councilman Hartwell seconded the motion. Roll calls all ayes. Motion carried.

The board discussed the property they want to buy with the Town Attorney. Since Supervisor Willis was out of town, the board made a phone call to him for his opinion. He advised them to have Attorney Vogel draw up a purchase offer and get it mailed to the property owner. Councilman Hartwell made motion for the attorney to do this. Councilman Jackson seconded the motion. Roll call, all ayes. Motion carried.

The Board audited General Fund Abstract # 5 (89-113) for \$19,540.59 and Highway Fund Abstract #5(46-63) \$ 27,223.71 and T/An abstract # 5 (5) for a total of \$110.

There being no further business before the board at this time Councilman Mahany made motion to adjourn, Councilman Rauber seconded it roll call all ayes motion carried Meeting adjourned at 7:55 PM.
