

The Town Board of the Town of Dansville, Steuben County, met on November 13, 2014, at 7:00 PM, for the regular monthly meeting and the Budget Hearing.

Also present: Ray Acomb (Hway Supt.), and Attorney John Vogel and from the public Nancy Jackson.

The Pledge of Allegiance to the Flag was observed.

At 7:10 Chmn Willis opened the Budget Hearing for comment or questions. None were made. Chmn Willis then advised that we continue with the regular meeting and would leave the Budget Meeting open for now.

There was no constable report as he was absent.

Attorney Vogel asked if we had gotten a response from Mr. Baldwin concerning the Comptroller's audit. Nancy will send him a copy to go over before she sends it to the Comptroller.

Highway Superintendent Acomb advised the board that 3 trucks were ready for snow plowing. The Hydraulic pump went on the 350 so it is being repaired at this time. He advised they have been cleaning ditches. The excavator still isn't right. The hoses aren't long enough since the Thumb was changed. Milton Cat is sending someone to fix the problem. Ray asked about adding a 14' X 16' addition to the shop for storage. Chmn Willis advised him to get some estimates. Councilman Mahany asked if it could wait a year or so till we could possibly build a new garage. No decision was made. Ray explained that the shop dumpster is being used from some local residents. And at times is overflowing. Nancy advised the board that another camera could be installed by our security people to face the shop and/or dumpster. After discussing Councilman Mahany made motion that we purchase the camera, Councilman Jackson seconded the motion. Roll call all ayes motioned carried. Councilman Mahany made motion to accept Ray's report, Councilman Jackson seconded the motion. Roll call all Ayes motion carried.

Nancy advised the board that Ted Robinson had to be reappointed for another 5 year term on the Board of Assessment Review. Motion was made by Councilman Jackson to reappoint Ted Robinson and Councilman Hartwell seconded the motion. Roll call all ayes motion carried.

It was advised that something should be done in memory of Ken Rauber. Nancy had picked up requests for Vincent House in Wayland and Dansville All Sports Booster Club. Councilman Mahany made motion to donate to both organizations, Councilman Jackson seconded the motion, roll call all ayes motion carried.

There were four inquiries for Ken's position. The board decided to wait to the next meeting to discuss them.

Also there were no inquiries for the 2 dump boxes. The board advised Ray to get an estimate and sell them for scrap.

The Supervisor's report was looked at. Councilman Mahany made motion to accept the report. Councilman Jackson seconded the motion. Roll call All Ayes, Motion carried.

The CEO report was read, there were no questions. Councilman Jackson made motion to accept the report. Councilman Mahany seconded the motion. Roll calls all ayes. Motion carried.

At 7:40 the board returned to the budget for a vote. There were no public present for comment. Councilman Mahany made motion to accept the motion, Councilman Hartwell seconded the motion. Roll call Mahany Aye, Jackson Aye, Hartwell Aye and Willis Aye. Motion carried Budget was approved. The board will meet Dec.23 for year end meeting.

The Board audited General Fund Abstract #11 (236-263) for 18,871.69, Highway Fund Abstract #11 (163-185) \$ 90,608.44 and T/A abstract # 11 (11) for a total of \$110.

There being no further business before the board at this time Councilman Mahany made motion to adjourn, Councilman Jackson seconded it roll call all ayes motion carried Meeting adjourned at 7:45 PM.
