The Pledge of Allegiance to the Flag was observed.

Chmn Willis asked public for any comments: Steven Kress advised that he wasn't against the windmills but is concerned about the noise level. Also prefers it not go buy his house.

Michael Shepard gave handouts on research he had done concerning noise levels.

The rep answered several questions concerning the probability of the windmills coming to our town. The total project includes 6 towns and possibly 10-14 could go in our town. All power for the towers goes underground and does not affect the existing power lines. He was thanked for his information.

Dog Control Officer Lackey no report as he was sick.

Attorney Vogel presented the new revised edition of Solar Law # 2016-05 to the board. He advised a public hearing would be needed at the January meeting.
