The Pledge of Allegiance to the Flag was observed.

Acting Chmn Mahany asked if there was anything from the public. Chad Graves was there concerning a piece of property that he thinks the town owns on Cty Rd 52. It is a small piece 16x82 that borders his property. He thinks it was abandoned by the town sometime in the 60's. He gave the board members a diagram of the property in question. He advised that Bryan Shu is his attorney. The board asked Attorney Vogel if he would talk to Attorney Shu for more information and advise the board at the next meeting. This was agreeable with Mr. Graves. No one else was present for the public.

Dog Control Officer Lackey wasn't present but left his report. Nancy advised that the problem that was discussed at the last meeting had been resolved. The party came in and licensed the dogs. Councilman Hartwell made motion to accept the report. Councilman Jackson seconded the motion Roll call all ayes motion carried.

Attorney: Attorney Vogel advised that he is working on 2 laws for the planning board. One being the sub division law and the other lowering the acre requirement to 2 acres from 3.

Highway Superintendent Acomb advised that the first round of grading has been finished on the dirt roads. They have been working on shimming road edges and cleaning ditches. The shared service loader is due to be renewed this fall. He advised that the Town of Fremont won't be renewing. Also it is possible that there will be no crushing next year. The crusher is broke down and it is getting hard to find parts for it. When our loader comes up for renewal it will be roughly \$ 20,000. Councilman Hartwell made motion to accept Ray's report. Councilman Jackson seconded the motion to accept the report. Roll call all Ayes. Motion carried.

The Supervisor's report was looked at. Councilman Hartwell made motion to accept the report. Councilwoman Stauring seconded the motion. Roll call all ayes motion carried.

The CEO report was read .There were no questions. Councilman Jackson made motion to accept the report. Councilman Hartwell seconded the motion. Roll call all ayes motion carried.

The Board audited General Fund Abstract #7 (131-160) for \$46,375.02.Highway Fund Abstract #7 (83-92) \$ 12,343.83 and T/A abstract # 7 (33) for a total of \$110.

There being no further business before the board at this time Councilman Mahany made motion to adjourn, Councilman Jackson seconded it roll call all ayes motion carried Meeting adjourned at 7:25pm.
