

The Town Board of the Town of Dansville, Steuben County, held the regular meeting on May 08, 2017 at 7:00pm.

Also present: Ray Acomb Highway Superintendent, Attorney John Vogel, and Dog Control/Constable Lackey.

The Pledge of Allegiance to the Flag was observed.

From the public: Priscilla Rowe Howe, Michael Shepard and Dave Dodge.

Dave talked to the board explaining what he will be doing to the building repairs. He plans on starting in a couple weeks.

Michael asked if there was anything new on the windmills. Attorney Vogel advised that he had been in contact with the Attorney representing Ever power. There still is a lot of work to be done before things start. Also John will be representing Wayland, Fremont and Dansville as the town's attorney for this project.

Dog Control Officer Lackey stated that the dog situation is getting better. He sent out 6 letters concerning cars. So far 4 have responded and taken care of them. Councilman Jackson made motion to accept the report. Councilman Jackson seconded the motion. Roll call all ayes. Motion carried.

The CEO report was given. There were no questions. Councilman Jackson made motion to accept the report. Councilwoman Stauring seconded the motion. Roll call all ayes carried.

Attorney Vogel discussed the need for a public hearing concerning the cable company and their changes.

Highway Superintendent Acomb advised that they were grading roads and ditching. He said the neighboring towns were helping out. Chmn Willis advised the Ray and the board that the State is working on something concerning Shared Services paperwork and accounting for the \$ spent. This will take a big amount out of the Shared Service fund. If there is some unexpected expenses down the road the boards will have to decide if they will contribute more money to the fund.

Ray said the Shared Service Dozer needs repairs. He had 3 estimates, the lowest being \$ 9286. The 3 town Superintendent agreed to have it done. Money comes out of shared services. The 284 was passed around for board members to sign. This has to be sent to the county. At this meeting the board refused to sign it. Ray was asked to revise it and bring it back at the next meeting. Ray advised that he had interviewed 3 of the best candidates' applications and decided to hire the one from Hornell. He is presently working at Blades. He was asked why he hired someone without presenting to board as he was asked at last month's meeting. Ray stated he had found a law that stated the board had nothing to say in the hiring. After lengthy discussions Ray was advised that he needed to work with the board more directly.

Motion was made by Councilman Mahany to accept the report. Councilman Jackson seconded the motion. Roll call all Ayes, motion carried.

The supervisor's report was gone over. Councilman Jackson made motion to accept the report. Councilman Mahany seconded the motion. Roll call all ayes motion carried. Attorney Vogel advised that he will have suggestions for the Ethics Law, The procurement law and the windmill law at the next meeting. He will be meeting with Mike Hoag the chairman and advise him the planning board needs to get something ready.

Chmn Willis asked for a motion to go into Executive Session for employee discussion. Councilman Jackson made motion, Councilman Mahany seconded the motion. Into executive session at 7:55 at 8:00 Councilman Mahany made motion to leave executive session. Councilman Jackson seconded the motion. Returned to regular session at 8:00. No decisions were made in executive session.

The Board audited General Fund Abstract #5(111-128) for \$31,321.26. Highway Fund Abstract #5 (66-82) \$ 13,117.84 and T/A abstract # 5 (6) for a total of \$110.00.

There being no further business before the board at this time Councilman Mahany made motion to adjourn, Councilman Jackson seconded it roll call all ayes motion carried Meeting adjourned at 8:05 pm.
